

Installation

1. Start MetaTrader4.
Select **File** in the menu, **Open Data Folder**. A new window will open:



Open **MQL4** folder. Here you will find **Experts** folder.


Copy **XScalper_EURUSD_M5.ex4** inside **Experts** folder.

2. **Close MetaTrader and start it again.**


Now you may find it under Expert Advisors in Navigator. Open EURUSD and M5 timeframe. Right-click on its name in Navigator and select Attach to a chart. Wait for few seconds for information to be displayed at your chart.

3. **Check Live Trading settings.**

Start MetaTrader4. For the proper live robot trading you need to check the following Options. Go to Tools in the main menu of MetaTrader4.
